b. Kyle Nelson, Community Health Service Program Manager for the Anav Tribal Health Clinic

Kyle Nelson requests for approval for the Anav Tribal Health Clinic to connect with the Tribe's Sage MIP software via VPN, install three additional user licenses, two additional modules (Fixed Assets and Grant Administration), create a separate company in Sage MIP, and begin using the software at the clinic for clinic's fiscal operations.

**b. Steven Tidwell, U. S. Public Health Service, Engineer**Jenny Holdin, Indian Health Service (IHS)
Sanitation Construction Program

### **Topic Discussed:**

- In 2008 we started a plan for a community drinking water system that would create a system that can be treated all at one time instead of treating individual wells.
- EPA did the water testing and contacted IHS and they came up and did the study.
- How fast can this project be done? About 120 days, depending on heavy weather
- Change order for break in the weather, would like to be done by December
- Transitions, down time could be a hour per home, will need to inform us so we can be prepared
- Payments programs, monthly
- Electronic system hookups
- Documentation of progress
- Force Account

QVIR will wait until the contribution comes in before this project will start. The payment information is already in place and construction payments are monthly.

EPA will be working with MLIHA to keep tenants informed and prepared for times when the water may be turned off

The EPA Director, Tribal Administrator and the MLIHA Resident Service Person will be the contact persons.

The Project Engineer will select the workforce and the hiring will be done by the tribe.

The Contractor and IHS will assist in the training.

On site documentation will be done daily and the Engineer will be on site around three days a week
