**b.** Vice Chairperson: PTI Audits, for the next three years.

## **Discussion:**

- Quartz Valley waives our right to use procurement this time and will send a waiver to BIA to state we are accepting PTI CPA Services, LLC.
- Tribal Vice Chairperson and Finance must meet next week to discuss the indirect cost proposal that is due.
- NGD money for Start Up Funds split 4 ways, Transportation, Cemetery, Fire House, Gymnasium
   Discussion: Cemetery, Add Baseball/ Softball Field

Harold Bennett makes a **motion** to add line item, Baseball and Softball, to Start Up Funds then split five (5) ways, Angela Lewis seconds, 16 For, 0 Against, 2 Abstentions

• Health Board Treasurer Cecilli Kelley sent a letter in with the Tribal Vice Chairperson who misplaced it. The Vice Chairperson states the Health Board Treasurer had a discussion with the Executive Director of the Anav Tribal Health Clinic over the \$60,000.00 Loan to Anav from Quartz Valley.

#### Discussion:

1. Forgive the loan, 2. Set up a payment plan, 3. Tribal Treasurer and Health Board Treasurer look into this. The money needs to go back to our people

**Directive:** The Tribal Treasurer must meet with the Health Board Treasurer to work on this loan issue and bring it back to the next General Community Council meeting.

- Fire Station: Up for the dry wall stage and looking at bids and looking at the least expensive materials
- Must look at Native American Business'

**Directive:** Vice Chairperson look into how much it cost for burials/funerals and bring back to the next General Community Council.

### **Discussion:**

- Fannie Mae / Freddie Mac Can get a breakdown of our investment from Housing Commissioner Chairman Harold Bennett, \$150.000.00 cash tied up in investments.
- Charlene Henry request a copy from Phil Bush of the Quartz Valley Indian Reservation Fannie Mae / Freddie Mac investments report to place in the minutes for February 11, 2012.

#### **Discussion:**

- When will be the next MLIHA Community Meeting?
- Workforce, training, how does someone get picked for this? Force Account Crew They train. Who hires? Final say goes to MLIHA Executive Director Phil Bush, the applicants go through a series of tests.

## **Discussion:**

 QVIR/ Grindstone funding. Does it hurt us if things are not getting done because of not having regular meetings?
 Can the meetings be here at QVIR four times a year, four times at Grindstone, and four times at Red Bluff?

#### Discussion:

- For the Change of Service Area, we need to get it in Resolution form. A survey will go out next week to find out what members are interested. We have a program that has not been funded. Right now our service area is only the Quartz Valley Indian Reservation. We can not help anyone until a program has been set up.
- Any HIP funds to moved to MLIHA, must meet HIP Regulations
- Henry Case asks, what are the assets that can be lost, to define breech of contract, and what are our assets should we divide from Grindstone? Discussion
- Phil Bush left an envelope that needs to be posted

## Discussion:

Vehicles need to go back to Cultural. We are going to have to find out how programs can pay for the gas / mileage, and what is the going rate for mileage?

- Sawmill: What do we want to do with the Sawmill? The sawmill needs its own policy, put using the sawmill on hold until we have one. Evette Lewis will bring in the old sawmill policy and give it to the Tribal Secretary.
- Baby Changing Tables: Range \$125.00 to \$400.00.

Evette Lewis makes a **motion** to purchase four baby changing tables, from Allied, AHD Grey, two (2) for the Gymnasium, and two (2) for the tribal office to place one in the ladies' restrooms and one

in the men's restrooms, Crag Smith seconds, 11 For, 1 Against, 3 Abstentions.

Q: Do the changing tables have a guarantee? What is the liability? Need a sign, use at your own risk.

e. Anay Tribal Health Clinic:

Evette Lewis makes a **motion** that who ever is sitting on the Health Board has to decide who is going to come to the General Community Council and give us a report. They must report at every General Council meeting, Charlene Henry seconds, 12 For, 0 Against, 3 Abstentions.

## f. Gymnasium Coordinator:

• Presented a copy of the Gymnasium Policy

#### Discussion:

- \$30.00 for cleaning deposit is too low
- Non-Tribal member-liability?
- Should only let Tribal Members check out the Gym for now.
- There are contracts in place
- Need to place into policy, maybe non-tribal pay the premiums for liability?
- We need to stay with just our members for now
- Gymnasium Coordinator think about this and bring back to the next General Community Council
- Should we build covers for the entrance for the Gym?
- Is there a time limit for renting the Gym?
- Need to improve the key issue, locking up when Gymnasium Coordinator is not there.
- While Gymnasium Coordinator is working is the Gym open? Yes. Aren't we using a lot of propane? Each room has its own heating. Fitness Center should be in the policy, supervision, under 16 years of age.
- Add from last minutes \$25.00 for a vendor

**Directive:** Gymnasium Coordinator goes through and fixes the policies and brings back to the next General Community Council

- Prize Bingo: First Prize Bingo will be on March 17, 2012. Angela Lewis is asking for help with setting up the Prize Bingo with a Bingo machine and some Bingo cards.
- Did she fill out a donation request?
- Do you have a Bingo Plan?
- Use the Start Up money under, Gymnasium.

Evette Lewis makes a **motion** to allow Angela Lewis to purchase a Bingo machine and some Bingo cards for the Gymnasium not to exceed \$500.00 out of, Start Up Funds line item, Gymnasium, George Super Sr, seconds, 13 For, 0 Against, 1 Abstention

Evette Lewis makes a **motion** to allow Joselyn Kelley to purchase 50 chairs and 5 large tables for the Gymnasium from Start Up Funds, line item Gymnasium. None of the tables or chairs may leave the Gymnasium, Alondra Bailey seconds, 14 For, 0 Against, 1 Abstentions

- Q: Can there be a space in the Gymnasium for the Johnson O'Malley items like the Christmas bulbs since they do a lot of functions at the Gym? A: Johnson O'Malley has a shed.
- Bake sale will be at the tournament
