- -Walking Trail- it is considered too much liability for the tribe
- -Gymnasium the floor was torn out, resulting in the contractor needing to up the price to buy the right materials to fix the pipes. Also we need to add a check valve to keep the pressure out of the pipes. The gym needs to be weatherized.
- -We need to find and train a water technician- this will be a paid position
- -WUIP crew- thinning and reducing fuels, the crew will be delivering wood- crew is doing a good job.
