Topic: Tribal Nations Fund:

 Release another \$245,000 for emergency protective measures. Create solutions to help high risk communities.
 Design and implement a program. Eligible activities:
 Salaries non-gaming tribal government operations and commercial enterprises, Sanitation supplies, basic life

- necessities, adequate housing, food, water, medication, medical care, utilities, grocery and meal services, etc.
- A new announcement with guidelines for reallocation of the already awarded Tribal Nations Fund \$400,000, to pay for COVID-19 related expenditure and established an Emergency Fund. It will need to be tracked, no income levels or requirements. Emergency Grant funds cannot be used for per capita payments.
- o Apply on-line for non-competitive equal distribution. This unique opportunity to service members and employees.
- o Application is Due April 30, 2020.
- o It will need to be tracked. Required to submit 2-reports

Topic: Payroll Protection Program-Loan

- o Receive 2-times the salary
- o Low interest loans, it's a benefit.
- Loans to be forgiven-no cost to tribe.
- o Paying and keeping the staff during this crisis
- o Tribal Administrator and GCCO will be working on it.
- Investigate the small business loan.
- Topic: Department of the Treasury and Bureau of Indian
 Affairs (BIA) are working on the CARES Act- Paycheck Protection
 Program- Employee Retention Credit
 - Discussion on how to distribute the monies. They are unsure of what formula for the funding distribution. Concerns: The larger tribes vs CA gaming tribe's vs smaller tribes.

- Topic: CA Office of Emergency Services
 - o The deadlines are running quickly
 - Placing the priorities on the funding

Joshua Stanshaw -Grants Compliance Contract Officer. Gives an update

 - o CDC Grants- CRIHB is applying.

- Non-clinic-based funding is gear towards Social Services programs.
- o They have 30 days to get the monies to the Tribes.
- Suggestion: Create objectives for assisting out of area members because of the high cost of rent, in the market.
- o General Welfare set up as Social Services structure.
- Our county is receiving tribal monies. There has been no communication.
